1. *Chlorophyll a* and *Chlorophyll b* were determined using a spectrophotometer (Shimadzu UV-1601) at 663 nm and 646 nm, respectively. The concentration of chlorophyll was calculated using the following formula: $\text{Chlorophyll } a = 12.7 \times \text{OD}_{663} - 2.8 \times \text{OD}_{646}$ and $\text{Chlorophyll } b = 22.9 \times \text{OD}_{646} - 9.6 \times \text{OD}_{663}$. The total chlorophyll concentration was calculated as the sum of chlorophyll *a* and chlorophyll *b*. The concentration of chlorophyll was expressed as $\mu\text{g mL}^{-1}$ of the culture medium.
